- Added materials to the table of benefits fairs.

## Bug Fixes:

- Fixed the bug that was preventing missing documents from being listed at the top of affiliate profiles.
- Fixed the display of sessions on cases where there is a paid affiliate invoice.
- Fixed bug that was preventing documents from being mailed to worklife vendors.
- Fixed issue that was causing manually created sessions on reassigned CC cases to have the wrong counselor attached.
- Fixed issue that was causing numbers on forms to adjust when scrolling within the field.
- Updated formatted research notes to always include live links.
- Fixed bug that was sometimes preventing organization audits from going out.
- Fixed bug that was causing rescheduled sessions to show crossed out instead of creating a new session.
- Updated the psychology today import feature to correctly add BCBS to the profiles of providers that accept BCBS insurance.
- Fixed bug that was preventing event portlets from loading.
- Fixed bug that was causing a 500 error when uploading documents to events.
- Fixed bug that was preventing users from editing tasks on organizations.
- Fixed bug that was preventing service approvals that were paid years ago from counting under units paid.
